- 2. Those who have already applied as *GAKUSHIN* (JSPS) 2011 and will apply 2012 special researchers. (If students have not applied, they will not be eligible for this program. However if students have the proper reasons, they will be eligible.)
- 3. Those who are already hired by similar budgets as this program are excluded.
- ** Note: Those who have been accepted by the Japan Society for the Promotion of Science as special researchers are eligible. However, these applicants must apply, and are reminded that the hiring decision as RA for this program will be announced after we receive instructions from the Ministry of Education, Culture, Sports, Science and Technology.

Amount of Fellowship

• Approx. A(Maximum 1,000,000yen) or B(Maximum 500,000yen) for this year in total.(However, this amount could change in adjustment process)

* For students accepted to *GAKUSHIN* (JSPS), the maximum working hours is basically 5 hours per week. (However, this applies only if *GAKUSHIN* (JSPS) allows one to work as an RA.)

• The Fellowship amount could change depending on the total working hours of Teaching Assistant and RA separately. Also, the amount could change depending on the specific research plans.
